## Trex<sup>®</sup> Big Game Deck Giveaway Official Rules

Details of rules and regulations

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- Eligibility: The Trex® Big Game Deck Giveaway (the "Sweepstakes") is open only to legal residents of the United States who are at least eighteen (18) years of age. - How to Enter: Entrant must follow @Trex\_Company on Twitter at the time of start of the contest. The "authorized account holder" is the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted email address. The Sweepstakes is subject to federal, state and local laws and regulations and is void where prohibited.
